

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.acrosslawpllc.com](http://www.acrosslawpllc.com), and A Cross Law Firm PLLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to A Cross Law Firm PLLC include [www.acrosslawpllc.com](http://www.acrosslawpllc.com). The A Cross Law Firm PLLC website is a Legal Services site. By using the A Cross Law Firm PLLC website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, A Cross Law Firm PLLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
